### The Institute

The African Institute of International Law, established in 2012 as an autonomous regional organization, is dedicated to promoting the rule of law, fostering research, and building capacity in international and African Union law for the development of Africa. Its prestigious Academy on African Union Law and the Public Law of Africa aims to provide participants with a deeper understanding of this distinct normative system, including the history, principles, and legal instruments of the African Union and its predecessor. Through lectures by leading scholars and practitioners, the Academy explores the innovative legal framework designed to realize Pan-African objectives, such as the right to intervene for peace and security, the condemnation of unconstitutional changes of government, and the promotion of human rights, democracy, and good governance.

### Certificate of Participation

### Tuition Fees
